This low profile polypropylene hook with polyamide backing was designed to be a strong performance self-engaging fastener.

Outdoor use

Since the product is made with polypropylene and polyamide, which both has a known tendency to degrade in UV light, the VELCRO® Brand ONE-WRAP® 229 fastener are not recommended for direct, prolonged exposure to UV light.



Resistance to solvents

The polyamide and polypropylene in this fastening system are resistant to cleaning with some solvents and to accidental exposure to common solvents, except for halogenated solvents, which dissolve it.

Their resistance to fluids used in transport, such as gasoline, motor oil or transmission fluids, has not been tested. We recommend testing the product for its specific application.



Fire resistance

The VELCRO® Brand ONE-WRAP® 229 fastener can be ignited. Please, see information related flammability properties in 'Special Characteristics'.



Water/Moisture resistance

Since the product is made with polyamide, this fastening system degrades its mechanical properties when exposed to water/high humidity (>80% RH) for long periods of time. These properties are typically recovered when the product dries.



Sterilisation

These products have not been tested for physical sterilisation (autoclave, steam, gamma rays, etc.) or chemical sterilisation (ethylene oxide, hydrogen peroxide, etc.).



Colour fastness
